This agreement is signed and executed electronically online by the below mentioned EEE Independent Distributor who has voluntarily out of his/her own accord and sweet will offered to join the Direct Selling Network business of M/s EffulgencEra Evolution Private Limited," a company registered under the Companies Act 2013 (Registration No. CIN –U51909PB2020PTC052255) having its Registered office at Near Hardyal Furniture House, 1st Floor, Hadiabad Road, SatnamPura, Phagwara, Kapurthala Punjab -144401 India. (Hereinafter called "Company" or "EffulgencEra" which expression shall, unless repugnant to the context, includes its successors in business, administrators, liquidators and assigns or legal representatives).

Whereas the company is engaged in "Direct selling" which means marketing, distribution and sale of goods or providing of services through a network of EEE Independent Distributor at different levels of distribution who may recruit or introduce or sponsor further level of EEE Independent Distributor, vide its own specific EEE Compensation & Marketing Plan not falling under a pyramid scheme.

And Whereas the EEE Independent Distributor who is named below along with his KYC particulars therein has, after being explained all the provisions of the EEE Compensation & Marketing Plan, product details and the present E-contract Agreement, in the language known to him by Mr/Mrs/Ms______ and

after visiting the company's website www.effulgencera.com and as certaining all facts, has voluntarily offered to join the business of the Company by Direct Selling mode and resolved to enter into this E-contract agreement, hence this deed.

Definitions:

The following word set in these presents shall have the meaning defined here under:

- a. "Company" means EffulgencEra Evolution Pvt. Ltd. having its registered office at Phagwara.
- b. "EEE" is a registered trademark of EffulgencEra Evolution Private Limited.
- $c. \quad \text{``Consumer'' means and includes individuals/body corporate (including Partnership Firms) who purchase products from EEE.}$
- d. "Direct Seller" is the person (including Company/Partnership Firms, proprietary concern) who is competent to enter into contract as per Indian Contract Act provided, such interested person has purchased products from the company and opted to participate into Business opportunity.
- e. He shall mean include male, female, body corporate, partnership <mark>firms who applies for the Distributorship</mark> of the Company.
- f. "Product" shall mean and include all the products marketed/sold by the company from time to time.
- g. "MRP" means and included Maximum Retail Price printed over the price tag each product.
- h. "Incentive" is the amount/benefit an independent distributer may earn by marketing/referring the products of MRP.
- i. "Statutory Deductions" means all statutory charges will be in force with immediate effect or as per the law prescribed.
- j. "Unique ID" means unique identification number issued by the company to the consumer/ EEE Independent Distributor and Unique ID is issued to the Independent Distributor as token acceptance of his application for direct sellership for the products of the company.
- k. "Password" means unique code allotted to the each cons<mark>umer/EEE I</mark>ndependent Distributor to allow them to log on the website of the company.
- I. "Website" means official website of the company www.effulgencera.com or any official website communicated through official communication channels of the company.

NOW THEREFORE THIS DEED COVENANTS AS UNDER:

- 1. The Company assures that this E-contract agreement has No provision that an EEE Independent Distributor will receive remuneration or incentive for the recruitment/enrolment of new participants.
- 2. The Company also assures that it does not requires a participant to purchase goods or services for an amount that exceeds an amount for which such goods or services can be expected to be sold or resold to consumers.
- 3. The Company also assures that it does not require a participant to pay any entry/registration fee, cost of sales demonstration equipment and materials or other fees relating to participation.
- 4. That an EEE Independent Distributor herein assures that it has ascertained from the EEE Compensation & Marketing Plan (The same may be read as part and parcel of this E-contract agreement), the stipulated amount of any type of remuneration like Incentives, rewards, etc. including financial and non-financial benefits payable to the EEE Independent Distributor are only and only for effective sale of products and in no way for recruiting/sponsoring/introducing an EEE Independent Distributor.
- 5. Cooling Off Policy: That the Company allows or provides to the EEE Independent Distributor herein a reasonable cooling off period of 30 (Thirty) days, from the date of execution of this E-contract agreement to participate or cancel his/her participation in the scheme and receive a refund of any consideration given to participate in the operations. The EEE Independent Distributor shall be responsible to give intimation to the company about such decision within specified period through E-mail or registered letter or speed post at company's mail ID/Registered address. The returned products should be in saleable condition i.e any seal/protection on the goods is kept intact and unbroken. The refund amount of such product shall be paid by the company within reasonable time of the date of receipt of the product at the Company's premises
- 6. **Buyback Policy:** That the Company allows or provides for a buy back or repurchase policy for "currently marketable" products sold to the participant at the request of the participant at reasonable terms on or before 30 (Thirty) days from date of purchase invoice of product(s). The Buyback Guarantee Mechanism as displayed on company's website may be read as part and parcel of this E-contract agreement.
- 7. That the EEE Independent Distributor herein agrees that the Company has established a "Grievance Redressal Mechanism" for consumers and EEE Independent Distributors to redress their grievances and complaints. The "Grievance Redressal Mechanism" is displayed on the website of the company. The EEE Independent Distributor or the customers can approach the Grievance Redressal Committee or the Grievance officer of the company for their grievances.
- 8. EffulgencEra Evolution Private Limited does not require an EEE Independent Distributor to invest money in any form whatsoever except the cost of products purchased by him/her and does not include any provision that the EEE Independent Distributor herein will receive compensation from the recruitment to participate. That he/she will receive compensation derived from the sale of products only.
- 9. That the Company will provide all support to the EEE Independent Distributor in delivery of the products through Franchisee/Pick-up centers / Courier Service for maintaining effective support system.
- 10. That for appointment of the EEE Independent Distributor herein the Company requires him/ her to do the following and he / she shall complete the following steps. An Individual/ Firm/Company who is able to do contract as per the provision of the Indian Contact Act, 1872 and wish to become an EEE Independent Distributor of the company, can apply to be appointed as an EEE Independent Distributor for marketing and selling of company's product on pan India basis, in prescribed form through online method.
 - a. Fill the application form online and upload scanned KYC documents.
 - $b. \quad Accept the terms and condition of this \textit{E-contract} agreement by clicking on \textit{``IAGREE''} button below.$
 - $c. \quad \text{On the completion of the above process, the EEE Independent Distributor can take a printout of this agreement.} \\$
 - d. Upon the execution of this agreement alongwith verification of all the documents through the above process, the applicant shall become the EEE Independent Distributor of the Company and Unique Identification number and password shall be allotted to the applicant, to allow him / her to log on to the official website of the Company i.e. www.effulgencera.com to access his/her own personal back office.
 - e. That the EEE Independent Distributor shall submit the following documents in hard copy to the company within 30 days from the date of execution of this Agreement (Including the acceptance of terms of appointment) by clicking on "I AGREE" button at the bottom of these presents (agreement) as well as all self- attested attached documents.
 - f. That the Company upon scrutiny and verification of the Application and KYC particulars may re-consider the decision of the appointment of EEE Independent Distributor for Direct Selling of products of the Company. The Company shall have sole discretion and liberty to reject his/her direct selling code, if the KYC and other documents in hard copy are found unsatisfactory, mollified or fake etc.
 - g. That the KYC shall include but not limited to verified proof of address, proof of identity and PAN. The EEE Independent Distributor shall submit PAN to the company as per the provisions of the Income Tax Act, 1961. The EEE Independent Distributor should also submit to Company, any photo ID Card as issued by the State or Central Government. These ID cards could be anyfrom the following:

11. Scope of the Work:

- a. That the EEE Independent Distributor shall market and sell the products of the company using word of mouth publicity, display and demonstration of the products, distribution of pamphlets, and door to door selling to consumers and prospective EEE Independent Distributors.
- b. That the company shall be exclusive owner of the name and logo of the company. The EEE Independent Distributor shall not use the EffulgencEra Evolution Private Limited trademark, logotype and design anywhere without written permission from the Company. This permission, if given, can be withdrawn at any time by the Company. Violations shall invite, besides termination of EEE Independent Distributor-ship of the Company, penal actions under the prevailing IPR laws and Rules.
- c. That the EEE Independent Distributor shall not manipulate the EEE Compensation & Marketing Plan, pricing of products, PV points etc., in any way whatsoever and shall not send, transmit or otherwise communicate any messages to anybody on behalf of the Company without prior written authorization for the same from the management of the company.
- d. That the EEE Independent Distributor will get specified percentage /points based Incentives pertaining to the sales for selling the company products directly or indirectly under this E-contract Agreement.
- e. That the Company hereby covenants that it shall provide to the EEE Independent Distributor with complete instruction books, catalogues, pamphlets for promoting sales and shall provide mandatory orientation training.
- f. That the company shall issue photo identity cards to EEE Independent Distributor. This photo identity card shall be returned by the EEE Independent Distributor to the company at the expiry/termination/revocation of the agreement and shall be destroyed. The identity card shall contain the Name & Unique ID number of the EEE Independent Distributor.
- The EEE Independent Distributor will not be authorized to collect any type of cheques/demand draft in his own name, on behalf of the Company. All cheques/demand drafts etc. should be drawn in the name of the company only and the same should be deposited with the company office or other offices as may be specified by the company, within a day. EEE Independent Distributor shall hold the said cash collection/cheque/DD in trust for and on behalf of the company. Upon failure to deposit the said cash collection/cheque /DD, EEE Independent Distributor shall be liable to pay damages/compensation and Mesne-profit, if any. The receipt/invoice issued by the company only would be valid documentary evidence in the hand of the consumer. It means EEE Independent Distributor would not be authorized to issue any receipt/invoice on behalf of the company.
- h. That the company may open following facilities for sale of its products:
 - i. Online Portal / E-commerce
 - Stores (Retail Outlets)
 - iii. Authorized Sales Point / Pickup Center
- 1. That every EEE Independent Distributor are not authorized to sell any product of the company one-commerce platform/marketplace. The EEE Independent Distributor is also prohibited from listing, marketing, advertising, promoting, discussing, or selling any product, or the business opportunity on any website or online forum that offers like auction as a mode of selling.

12. Sales Incentives / Commission Structure or other Benefit that the Independent Distributor shall enjoy the following privileges:

- a. Sales Incentive related to their respective sales volume as per the EEE Compensation & Marketing Plan.
- b. Earnings of the EEE Independent Distributor shall be in proportion to the volume of sales done by the EEE Independent Distributor by self or through his/her network team as stipulated in the EEE Compensation & Marketing Plan.
- c. EEE Independent Distributor can Market/sell Compa<mark>ny Products</mark> on Pan India basis. There is no territorial restri<mark>ction</mark> to sell the products.
- d. He/she can always check and inspect his/her account on the company's website by using Unique ID and Password allotted to him/her by the company.
- e. That the Company reserves the right to restrict the list of products for a particular area / region.
- f. That price revisions, Government directives, market forces etc.,may lead to change in the Company Sales Incentives policy and the company's decision in this regard will be final and binding. In all such cases, the amendments will be notified on the company's website and such notifications shall be binding on the EEE Independent Distributor. However, if any EEE Independent Distributor does not agree to be bound by such amendment, he/ she may terminate this agreement within 30 days of such publication by giving a written notice communicating his / her objections, if any, to the Company. Without submission of the objection for modification etc., if an EEE Independent Distributor continues the Direct Selling activities then it will be deemed and presumed that he/ she has accepted all modifications and amendments in the terms & conditions for future.
- g. That all payments and transactions shall be valued in Indian Rupees (INR).
- h. That the Company does not guarantee/assure / promise or offer any facilitation fees or any amount or quantum of income whatsoever to the EEE Independent Distributor on account of becoming an EEE Independent Distributor of the Company.
- i. That Sales Incentives to the EEE Independent Distributor shall be subject to all statutory deductions as applicable like TDS etc.
- j. That Sales Incentive paid to the EEE Independent Distributor is inclusive of all taxes.
- 13. That the company shall provide accurate and complete information to prospective and existing EEE Independent Distributors concerning the reasonable amount of earning opportunity and related rights and obligations.
- 14. That the company shall pay all dues to the EEE Independent Distributor and make withholdings, if any, in a commercially reasonable manner.
- 15. That company does not require an EEE Independent Distributor to maintain an office or establishment in furtherance of his/her entrepreneurship and if an EEE Independent Distributor does so then he / she himself/herself will be responsible to bear such expenses and the Company will in no way be responsible to refund or reimburse the same.
- 16. That EEE Independent Distributor covenants with the Company that it will exclusively engage in the sale of the company products and shall not indulge in the sale of similar/identical products.
- 17. That Unique Identification Number will have to be quoted by the EEE Independent Distributor in all his/her transactions and correspondence with the Company. The Unique Identification Number once allotted cannot be altered at any point of time. That No communication will be entertained without Unique Identification Number and password. EEE Independent Distributor shall preserve the Unique Identification Number and Password properly as it is must for logging on to website.
- 18. That the EEE Independent Distributor shall be faithful to the Company and shall uphold the integrity and decorum to the Company and shall maintain good relations with other EEE Independent Distributor and customers also.
- 19. That the EEE Independent Distributor shall abide with policies, procedures, rules and regulations prescribed by the Company as well as all laws, rules, regulations, directives and Guideline issued by Government of India, a State Government, a Local body, a Court of Law and local administration, from time to time. An EEE Independent Distributor will also not indulge in any deceptive or unlawful trade practices as defined in the Consumer Protection Act, 2019 and if does so then he/she shall be solely responsible for the consequences thereof.
- 20. That the EEE Independent Distributor shall be liable to produce/show/explain the EEE Compensation & Marketing Plan to the prospects as has been received by him/her. If the company notices that the EEE Independent Distributor is working in a way not permitted/authorized, then the company shall have exclusive power to terminate or bar him/her from the company's EEE Independent Distributor-ship after giving a show cause notice.
- 21. That the EEE Independent Distributor cannot conduct or announce personal level business promotion activities by offering cash rewards, trips, valuables, etc.
- $22. \ That the \textit{EEE} Independent \textit{Distributor} is personally liable for delivery of goods to its customers. He is also liable to collect products from where it reaches last by the transporter. \\$
- 23. That the EEE Independent Distributor shall not use or advertise on social media any business promotion material, not authorized or approved by the Company and if he/she does so then he/she shall solely be responsible for the consequences.
- 24. That the EEE Independent Distributor is prohibited from mentioning / posting / telecasting any inappropriate or defaming content about the company, its products, etc. in any social media platforms. If he / she does any act in contravention to this clause, then this contract agreement will be deemed terminated and the company reserves rights to initiate appropriate legal action against him / her.
- 25. All consumers / EEE Independent Distributor should physically visit our nearest franchise outlet or office to verify and experience the look and feel of EEE Products which are available at the display. Once our consumer / EEE Independent Distributor is satisfied, he/she can either order online or make the purchase instantly. Consumers / EEE Independent Distributors should note that the images displayed on our website / printed marketing collaterals are only for reference and therefore the actual product may vary. The product prices and specification are also subject to change from time to time and are under discretion by Management.
- 26. That the EEE Independent Distributor hereby undertakes not to compel or induce or mislead any person with any false statement /promise to purchase products from the Company or to become EEE Independent Distributor of the Company.
- 27. All statutory changes will be in force with immediate effect or as per the law prescribed.
- 28. Any notice or correspondence/s addressed and sent to the EEE Independent Distributor's address, E-mail ID and Mobile Number mentioned in the Application Form for registration as EEE Independent Distributor by registered AD post or a Courier Service or E-mail or Whatsapp message shall be construed as legally delivered to the addressee. However, it is advisable that every EEE Independent Distributor shall immediately inform the company about the change in his / her address, E-mail ID and Mobile Number failing which the EEE Independent Distributor's non-deliverance claim shall not be tenable at any cost whatsoever.
- 29. The term of this E-contract agreement is at will, subject to earlier termination in accordance with this E-contract agreement or in accordance with law. If this E- Contract Agreement is terminated for any reason whatsoever, the EEE Independent Distributor understands that his / her right to sell the products and receiving incentives with respect of his/her activities as an EEE Independent Distributor will cease immediately. Company reserves the right to terminate this E-contract agreement if any condition(s) of this E- Contract Agreement are violated by an EEE

Independent Distributor.

- 30. Limitation of Action: If an EEE Independent Distributor wish to bring an action against the company for any act or omission relating to or arising from the agreement, such action must be brought within ninety (90) days from the date of the alleged conduct given rise to the cause of action. Failure to bring such action within the given time shall bar all claims against the company. EEE Independent Distributor waives all claims that any other statutes of limitations apply.
- 31. Indemnification: That the EEE Independent Distributor agrees to protect, defend, indemnify and hold harmless Company and its employees, officers, directors, agents or representatives from and against any and all liabilities, damages, fines, penalties and costs (including legal costs and disbursements) arising from or relating to:
 - a. Any breach of any statute, regulation, direction, orders or standards from any governmental body, agency, or regulator applicable to the company; or
 - b. Any breach of the terms and conditions of this E-contract agreement by the EEE Independent Distributor,
 - c. Any claim of any infringement of any intellectual property right or any other right of any third party or of law by the EEE Independent Distributor; or
 - d. Against all matters of embezzlement, misappropriation or misapplications of collection/money which may from time to time during the continuance of the Agreement come into his/her /its possession/control.
- 32. **Relationship:** That the EEE Independent Distributor understands that it is an independently owned business entity and this Agreement does not make it, Company's employee, associate or agent or legal representative of the company for any purpose whatsoever. The EEE Independent Distributor does not possess any express or implied right or authority to assume or to undertake any obligation in respect of or on behalf of or in the name of the company or to bind the company in any manner whatsoever. In case, an EEE Independent Distributor violates this provision in any manner whatsoever then he/she shall be responsible for all types of consequences be it financial, statutory, civil or criminal.

33. Suspension, Revocation or Termination of E-contract agreement:

- a. That the company reserves the right to suspend the operation of this E-contract agreement, at any time, due to change in its own license conditions or upon directions from the competent government authorities. In such a situation, company shall not be responsible for any damage or loss caused or arisen out of aforesaid action.
- b. That in case of violation of any of the provisions of this agreement stated here-in-before and agreed upon by the EEE Independent Distributor, the Company may, without prejudice to any other remedy available, issue a one month's written notice and call upon the EEE Independent Distributor to explain his conduct in writing failing which or if the explanation is found unsatisfactory, suspend/block/terminate the EEE Independent Distributor from further conducting the business of the Company.
- $c. \quad That the EEE Independent Distributor may terminate this agreement at any time by giving a written notice of one month to the Company at the Registered address of the company. - 34. Actions pursuant to Suspension / Blocking / Termination of this E-contract agreement: That notwithstanding any other rights and remedies provided elsewhere in the agreement, upon termination of this agreement:
 - a. The EEE Independent Distributor shall not represent the company in any of its dealings.
 - b. The EEE Independent Distributor shall not intentionally or otherwise commit any act(s) as would keep a third party to believe that the company is still having Direct selling agreement with the EEE Independent Distributor.
 - c. The EEE Independent Distributor shall stop using the company's <mark>name, trademark, logo, etc., in any a</mark>udio or visual form.
 - d. All obligations and liabilities of such EEE Independent Distributor to the company existing on the date having accrued during the validity of this Agreement will have to be fulfilled, met and satisfied by the EEE Independent Distributor in every manner whatsoever.

35. Governing Laws and Regulations

a. That this Agreements shall be governed by the provisions of the Indian Contract Act, 1872, the Consumer Protection Act, 2019, Direct Selling Guidelines, 2016 notified by the Government of India and State/Union Territory Governments as well as all other rules and regulations issued by the Government of India and State Governments / Union Territories.

36 Dispute Settlement

That In the event of any interpretation of any question of law, dispute or difference arising under this agreement or in connection there-with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to a legal forum having jurisdiction in Phagwara (Punjab, India). Disputes if any shall be resolved in accordance with the provisions of the Indian Arbitration and Reconciliation Act and mediation provisions of Consumer Protection Act, 2019.

37. Force-Majeure

That if at any time, during the continuance of this agreement, the performance in whole or in part, by the company, of any obligation under this is prevented or delayed, by reason of war, or hostility, acts of the public enemy, civic commotion, sabotage, Act of State or direction from Statutory Authority, explosion, epidemic, quarantine restriction, strikes and lockouts, fire, floods, natural calamities/Disaster or any act of God (hereinafter referred to as event), neither party shall, by reason of such event, be entitled to terminate the agreement, nor shall either party have any such claims for damages against the other, in respect of such non-performance or delay in performance. Provided that the Services under the agreement shall be resumed as soon as practicable, after such event comes to an end or ceases to exist.

38. The Independent Distributor hereby covenants as under:

- a. That he/she has clearly understood the application form, EEE Compensation & Marketing Plan, its limitations and conditions and he/she is not relying upon any representation or promises that is not set out in this E-contract agreement.
- b. That relation between the Company and the EEE Independent Distributor and all his/her activities here under shall be governed in addition to this agreement, by the rules / procedures contained in the EEE Compensation & Marketing Plan, available on website. The EEE Independent Distributor confirms that he/she has readout all the terms & conditions thereof and agrees to be bound by them.
- d. That EEE Independent Distributor, hereby declares that all the information furnished by him/her to the Company are true and correct. Company shall be at sole discretion and liberty to take any action against the EEE Independent Distributor in the event, it is discovered that the EEE Independent Distributor furnished any wrong/false information to the Company.
